TO THE QUALIFIED ELECTORS OF LAKE COUNTY: NOTICE IS HEREBY GIVEN THAT AN ELECTION WILL BE HELD IN LAKE COUNTY ON TUESDAY, NOVEMBER 8, 2022. THE POLLS WILL BE OPEN FROM 7:00 AM TO 8:00 PM to vote for Governor, Secretary of State, Attorney General, State Senator (33<sup>rd</sup> and 34<sup>th</sup> District), U.S. Representative in Congress (2<sup>nd</sup> District), State Representative (100<sup>th</sup> District and 101<sup>st</sup> District), State Boards, Justice Supreme Court, Judge Court of Appeals (4<sup>th</sup> District), County Road Commissioner (1), County Commissioners (All Districts), Township Supervisor Partial Term (Peacock), Township Clerk Partial Term (Cherry Valley, Peacock, Dover, Sweetwater and Ellsworth), Village Supervisors and Trustees (Baldwin and Luther), Township Treasurer Partial Term (Sauble), Trustee Partial Term (Sauble and Webber), School Board Members (Baldwin, Pine River, Reed City, MCE, MCC, Cadillac, KND and WSCC) and the following proposals:
