2.65% will be added to your credit/debit card payments. \$2.95 flat fee is added to eCheck payments. The township does not charge this fee, nor do we receive any portion of it.

1% per month interest will be added after 2/14/23. On March 1, 2023, delinquent property taxes are payable to the Lake County Treasurer in Baldwin, MI with additional interest and penalty.

FROM THE CLERK, Gail Raad: Thank you to all the registered voters in Sauble Township. Our township had the biggest turnout of all the townships in Lake County. The August Primary had 41.2% and the State General Election held on November 8, 2022, had 68.7%. 112 elected to vote by absentee ballot while 145 of you made the trip to vote in person at the township hall. Thank you to Sue Ann Knott, Mary Ann Nugent, JoAnn Rogers, and Diana Venema who ensured that the election process was conducted fairly and professionally. With the passing of State Proposal 22-2 changes will be coming to the election process in 2023 and Sauble Township will be ready to enact them.

FROM THE SUPERVISOR, Mary Ann Nugent: Thank you for all your support, encouragement, and willingness to assist with township projects and functions. The Township Board has faced some challenges in the past year; however, we have worked to resolve them with determination and professionalism for the betterment of the Township. We appreciate the positive reassurance the community has shown us and are looking forward to a wonderful 2023 in Sauble Township.
