2.65% will be added to your credit/debit card payments. \$2.95 flat fee is added to eCheck payments. The township does not charge this fee, nor do we receive any portion of it.

1% per month interest will be added after summer tax due date. On March 1, 2023, delinquent property taxes are payable to the Lake County Treasurer with additional interest and penalty. Check (made out to Sauble Township) must clear or receipt is void. Postmarks are not accepted. For receipts, send self-addressed, stamped envelope to 8906 W 6 Mile Rd, Irons, MI, 49644.

FROM THE CLERK, Gail Raad: If you are a registered voter in Sauble Township you are eligible to vote in the following elections. The Primary Election will be held on Tuesday, August 3, 2022. The General Election will be held on Tuesday, November 8, 2022. The polls are open from 7 A.M. to 8 P.M. on both dates. You have the option of voting in person or by absentee ballot.

PLANNING COMMISSION: The Planning Commission has completed the review of the Draft **Zoning Ordinance**. Next steps are Township Board Approval, Attorney Review, and Public Hearing.
