1% per month interest will be added after 9/14/23. On March 1, 2024, delinquent property taxes are payable to the Lake County Treasurer with additional interest and penalty. **FROM THE SUPERVISOR, Mary Ann Nugent:** The Sauble Township Hall has had some exterior work done in the last year. With the use of township & ARPA funds, and donations, we have replaced the 30-year-old roof, new soffit/fascia, new siding, and new insulation. The township hall was originally built as a school in 1907 and we are determined to maintain it to preserve history. Additional plans for ARPA funds are replacement of carpeting/vinyl flooring and replacing the old copier. We are looking at writing grants for a generator as well.
