# Siding Project Update

# • Update on Use of Station #1

- Review lease agreement to be made between Sauble Township and the Lake County Sheriff Department
- Have Sheriff Department pay for 50% of the electric bill. Currently no heat or water are available in the building. Lease can be renegotiated at any time. Mark Pietras, Under Sheriff, will present to the Lake County Board of Commissioners.
- MMRMA will insure the building with Sauble Township as payee. Sheriff Department will
  insure and pay the cost for the vehicles stored in the building.
- Nugent motion to move forward with the lease agreement for the use of the fire station by the
  Lake County Sheriff Department. Sauble attorney, Alex Henderson, will update the lease
  agreement to include sharing 50% of the electric bill and if at all possible for lease agreement to
  begin on the first day of the month. Second by Baker. Roll call vote: Nugent, yes; Raad, yes; Acker,
  yes; Snow, yes; Baker, yes. Motion carried.

# Generator (Grant funded)

- Nugent attended a grant workshop for LCCF application. Grant money has been increased to \$10,000.
  - Write a Mission statement.
  - Will not be an official designated shelter.
  - Nugent will call Wolverine Power Supply for a quote, Raad will provide Nugent with the Company who installed Elk Township's Generac.

# Discussion on 2023-2024 Budget

- Increase of \$900 to Supervisor salary
- \$300 per diem to Clerk for every election due to Proposal 22-2 regarding election changes
- Increase of \$2 to Hourly wages (from \$13 to \$15) for election workers, board of review members etc.
- Adding extra money to assessor for possibility of costs incurred due to Pleasant Acres
   Trailer Park contacting the MI State Tax Tribunal
  - Pleasant Acres Trailer Park presented a petition at Board of Review objecting to assessor, Greg Barnett, calculations.
  - Board members will support Greg Barnett's decision as to how to proceed.
- o Adding extra money to Zoning for zoning violations such as blight
- Adding extra money to Board Audit/Professional for attorney fees
- Adding extra money to elections for August School and Presidential Primary. Should be reimbursed for most of the expenses.

Nugent and Raad will finalize the budget prior to the March 27,2023 board meeting.
